3. Death Certificate.
4. Proof of bank account ownership for the account to which the interim payment will be transferred.

To apply for an interim payment for personal injury:

1. Proof of identity of the deceased: valid ID (Passport, National Identity Card/DNI or Foreign Resident ID/NIE)
2. Medical report, Discharge Summary, or certification confirming continued hospital admission.
3. Proof of bank account ownership for the account to which the interim payment will be transferred.
