



## TRAVELER'S DECLARATION OF RESPONSIBILITY

2.- That the animal complies with all mandatory health and preventive regulations.

3.- That, in order to cover any damage or loss that the animal may cause, whether travelling with  
its owner or not, I hold a civil liability insurance policy number

sufficient and appropriate coverage and limits (indicate limit

assume responsibility for any damage or loss caused by the animal that is not covered or that  
exceeds the limits insured in the civil liability policy.

4.- That, during the journey as well as when boarding and leaving the train, I will strictly comply  
with the applicable regulations, as well as with the conditions established by Intermodalidad de  
Levante, S.A. and any instructions received from its staff, ensuring that the animal does not cause  
fear, inconvenience, danger, threat or damage to other passengers, other animals, staff members  
or railway equipment.

5.- By ticking the box, I give my consent and expressly authorize Intermodalidad de Levante, S.A.  
(hereinafter, "IRYO") to capture and use images of me together with my dog during my journey  
with my pet, both on the train and in stations.

6.- By ticking the box, I authorize IRYO to disseminate, reproduce and distribute such images for  
the purpose of promoting among passengers the possibility of travelling with dogs on iryo trains  
through IRYO's communication channels. These images may be used to share customers'  
experiences travelling with large pets, always in compliance with Organic Law 1/1982 of May 5 on  
the right to honour, personal and family privacy and one's own image, Regulation (EU) 2016/679  
of the European Parliament and of the Council of 27 April 2016 on the protection of natural  
persons with regard to the processing of personal data and on the free movement of such data,



and Organic Law 3/2018 of December 5 on Personal Data Protection and guarantee of digital rights.

The present authorization, granted free of charge, will have commercial use and will not be subject to any time limit nor restricted to any specific geographical scope, except as legally provided.

7.- That I am aware that IRYO may contact me to propose my participation in surveys, in-depth interviews and other qualitative research techniques that may be carried out in person, by telephone or by electronic means in order to learn about my experience.

8.- That I have read the information regarding data protection and consent to my data being processed in accordance with the purposes described.

9.- That the information provided in this declaration is true and I undertake to report any modification that may occur before the trip by submitting a new declaration.

10.- That I have read and accept to comply with the conditions contained in the document entitled "Obligations for Travelling with Large Dogs" available on the iryo website, as well as those contained in this Declaration of Responsibility.

- I expressly authorize IRYO to capture and use my image together with my dog during the journey, both on trains and at stations, and to disseminate, reproduce and distribute such images under the terms established in section 6 of this Declaration.

(2) Legitimate interests pursued by the data controller in relation to the surveys or consultations sent. (3) Consent of the data subject for the processing of their image.
5. **Recipients:** Your data will not be disclosed to third parties unless necessary for the purposes described, when there is a legal obligation, or upon request from public administrations, ADIF, Courts and/or Tribunals.
6. **Retention periods:** Personal data will be retained by IRYO for the retention periods related to the ticket purchase process, after which they will be blocked and subsequently deleted once the applicable limitation periods have expired.
